Church council update:

Special congregational meeting – October 3rd during service.

Please plan to attend. The reason you ask? A glitch in the language of our by-laws...we were advised by the title examiner at Hillsboro Title that our bylaws do not give any authority to sell the 6 acres to the Schraders. Our bylaws state that “church property is indivisible”. Also, while the council can make many decisions with the consent of the congregation, the bylaws do not state specifically that council can sell property. The closing of the sale of the property is on hold until we make modifications, which, of course, require the consent of the congregation.

We have an attorney assisting with the modifications. At services on Sept. 18 and 25, council will have available the proposed modifications to the bylaws. On those dates, we will also announce the special meeting to vote on the changes on October 3. The proposed changes will be available in “hard copy” on the 18th, 25th, and Oct. 3rd. The changes will be e-mailed to those on the church e-mail. The special meeting will be announced on OneCall during the weeks of October 18th and 25th. Any questions? See Jack

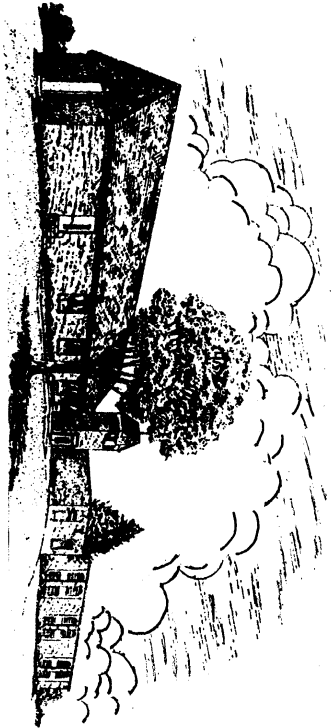

Normal this year, however, still will not look like it has in the past. We aren't even far enough along in the recovery from this international pandemic to say that we have come to a sense of a NEW normal!

I am sad that our traditions, like the Fall Festival and making Apple Butter which mark the time for us and our whole surrounding community, won't be able to take place as they have in the past. This is just one more loss on top of many which we have all had to accommodate these days.

The 'disease' which is spreading has affected all of life – and THAT is what I am leading up to. The prayer is called, "Be Our Primary Disease!"

RESPONDING IN LOVE

Do not resist an evildoer. But if anyone strikes you on the right cheek, turn the other also.

Matthew 5:39 (NRSV)

My older brother ran down the stairs with tears streaming from his eyes. A few seconds later I followed, trying to keep up with him on my little, three-year-old legs. When my brother and I entered the living room, my mom was startled and concerned. She asked my brother, "What's wrong? Why are you crying?" My brother answered through his tears, "Grant hit me for no reason!" Before my mom had a chance to respond, I exclaimed, "That is not true! He is lying! I didn't hit him for no reason; I kicked him for no reason!" This story from my childhood makes me laugh, but I also feel bad about the way I treated my brother. He didn't deserve it.

Sometimes we're treated in ways we don't deserve. Whether a friend abandons us, a co-worker gossips about us, a family member manipulates us, or a boss undervalues us, our tendency is to retaliate. But Jesus calls his followers to respond differently.

In today's reading, Jesus speaks about how his listeners have twisted God's words to justify revenge. But then Jesus urges his followers to respond in a different way. Even when we're treated in ways that we don't deserve, Jesus calls us to respond with love .

Anna Belle Wakeland-a Junior at Grandview High School just made All-District Choir. Luke Meier a Freshman at Northwest High School recently raced on the JV Cross Country Team at Cape Girardeau and placed 12 out of 114. Luke continues to improve his Personal Record and help his team.

Youth Graduates:

Austin Smith and Allison Wakeland are two of our "Youth Graduates". I want to take the time to brag a little and focus on their recent Awards. Another example of how our Youth continue to make us proud!! Austin Smith attends Missouri Baptist University. Austin was recently awarded an MBU Champion of Character Award. This is awarded by the University Athletic Department. The award is only given to one male and one female each year. They are chosen from roughly 800 student athletes who best exemplify the ideals of Missouri Baptist University and the NAIA's five core values of integrity, respect, responsibility, servant leadership, and sportsmanship. The student-athlete must also have a cumulative GPA of 3.0 or higher. This is the article published regarding Austin: Austin Smith-Men's Wrestling-St. Charles, MO Smith serves on the Student-Athlete Advisory Council for Men's Wrestling and carries a 3.90 cumulative GPA as a Forensic Psychology major. The St. Charles, MO junior has collected several awards including the 2020-21 Daktronics-NAIA Scholar-Athlete award, two President's Citations, two Dean's List Citations and two Academic All-AMC honors. The local product of Francis Howell Central High School is a prime example of a servant leader volunteering with Special Olympics and having taken two mission trips; one to Bayou La Bare, AL, to help clean up damage from Hurricane Katrina and one to Buffalo, NY to do community work including home repairs, summer programs for area youth, and helping with repairs on one of the oldest Catholic Cathedrals in New York. Smith is also a contributor (writer and editor) for Devozine, a devotional book for teens under the same company as "The Upper Room". Austin will be formally inducted into the Athletics Hall of Fame class and will be honored next month at the 2021 Spartan Athletics Hall of Fame Banquet.

Allison Wakeland attends St Louis College of Pharmacy. Allison was selected for A.O. Duer Award. The NAIA has selected UHSP cross country and track and field athlete Allison Wakeland as the 2021 winner of the A.O. Duer Scholarship Award. The National Award comes after Wakeland was selected as the American Midwest Conference NAIA nominee. The A.O. Duer Scholarship is awarded to one male and one female student-athlete in any sport who have excelled in scholarship, character, and citizenship. Wakeland will be presented with a certificate and a \$1000.00 scholarship as a recipient of the national award. She will also be recognized at an annual function in April. Wakeland is a Cross Country National Qualifier and All-Conference runner for the Eutectics, she has maintained a 3.88 GPA in the pharmacy program while simultaneously playing a crucial role on the Eutectic cross country and track and field teams and in the community. On Campus, Allison serves in several leadership positions. The list includes being the President of the Kappa Epsilon, the team captain of the cross country and track and field teams, the secretary of the Student-Athletic Advisory Committee and was recently elected to a leadership role in the Pharmaceutical Cosmetic Club. In addition, she serves as a resident advisor. Allison is a true asset. She is a hard worker, intelligent, and has the ability to make everyone smile. Her volunteer work is also high on Wakeland's priority list. She has committed time to help with Food Outreach, preparing meals for HIV patients, working in the St Louis University Adult Clinic, COVID vaccine clinics, and a Forest Park greenhouse project called Blitz Blooms. Her work as an intern at the Siteman Cancer Center at Washington University is equally impressive. The Siteman Cancer Pharmacy manager writes, she does an outstanding job working in the investigational drug service space and is a true pleasure to work with. She demonstrates a true interest to research.
